

VOODOO RANGER BET ON 11 SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. ALTERNATE METHOD OF ENTRY AVAILABLE AS DESCRIBED BELOW.

1. Sweepstakes Details

The Voodoo Ranger Bet on 11 Sweepstakes (the “Sweepstakes”) consists of up to six (6) separate entry periods (each, an “Entry Period”) as set forth in the chart below (collectively, the “Sweepstakes Period”). The Sweepstakes begins on March 9, 2026, and, in any event, will end no later than April 6, 2026. The commencement of any subsequent Entry Period is contingent upon the occurrence of a Qualifying Event during the immediately preceding Entry Period.

For purposes of this Sweepstakes, a “Qualifying Event” means that, during the applicable Entry Period, at least one (1) men’s Division I college basketball team designated as an eleven (11) seed in the NCAA Division I Men’s Basketball Championship tournament wins a tournament game, as reflected in the NCAA’s final, official results.

If a Qualifying Event occurs during an Entry Period, the Sweepstakes will continue to the next scheduled Entry Period. If a Qualifying Event does not occur during an Entry Period, the Sweepstakes will automatically terminate at the end of that Entry Period. Notwithstanding the foregoing, if all eleven (11) seeded teams are eliminated during the first round of the tournament, the Sweepstakes will automatically terminate at 11:59:59 p.m. Eastern Time (“ET”) on March 20, 2026.

Sponsor’s determination of whether a Qualifying Event has occurred shall be based solely on the NCAA’s final, official results. Subsequent corrections or statistical adjustments will not affect administration of the Sweepstakes. Entries do not carry over between Entry Periods.

The occurrence or non-occurrence of the Qualifying Event does not require any action, prediction, or wager by participants and does not affect the method of winner selection. The Qualifying Event is used solely to determine whether additional Entry Periods will be conducted. The Sweepstakes is a game of chance and does not constitute wagering, betting, or gambling.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes.

2. Eligibility

This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia, excluding Utah, who are at least twenty-one (21) years of age at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies, vendors (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, alcoholic beverage suppliers, wholesalers, distributors, and importers, and alcoholic beverage retailers and their employees and family members, are not eligible to enter or win. All applicable federal, state, and local laws and regulations apply. Void where prohibited or restricted by law.

3. Sponsor and Administrator

4. How to Enter

During an Entry Period, eligible entrants may visit www.betoneleven.com ("Website"). Follow the links and instructions to complete the entry form which may include, but is not limited to, entrants full first and last name, complete mailing address (street address, city, state, zip code – no P.O. Boxes), valid email address, phone number, date of birth, and agreement to these Official Rules. Then follow the steps to upload a receipt showing a valid purchase of any Voodoo Ranger product. A purchase is not required and does not impact the odds or chances of winning a prize.

Alternate Method of Entry: To enter without making a purchase or uploading a valid receipt, you may visit the Website, follow the links and instructions to complete the entry form and submit a photo showing how you support your favorite team. Same chances to win.

Upon submitting the required information and a receipt or photo, entrant will receive one (1) entry into the applicable Entry Period. Photos will not be judged or used in anyway to determine winners. Completing a purchase and uploading a receipt will not impact your chances of winning.

Limit: Regardless of the method of entry, there is a limit of three (3) entries per person, per Entry Period, during the Sweepstakes Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries using automated systems, multiple/different email addresses, identities, registrations, or any other methods will void that entrant's entries and will result in disqualification.

Winning a prize is contingent upon fulfilling all requirements set forth herein. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. For

purposes of this Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

5. Random Drawing(s)

Winner selection will be conducted by Administrator, whose decisions, along with the decisions of Sponsor, will be final and binding in all matters relating to this Sweepstakes.

Regardless of whether a Qualifying Event occurs, Administrator will randomly select one thousand one hundred (1,100) potential Second Prize winners from all eligible entries received during Entry Period 1 on or around March 23, 2026.

Contingent Prizes:

All other prizes (Grand Prizes, First Prizes, and Third Prizes) are contingent upon the occurrence of a Qualifying Event during the applicable Entry Period.

If a Qualifying Event occurs during an Entry Period, Administrator will conduct the corresponding random drawing(s) for that Entry Period on or about the date(s) set forth in the chart below, from among all eligible entries received during that Entry Period.

If a Qualifying Event does not occur during a given Entry Period, no Grand Prize, First Prize, or Third Prize drawing will be conducted for that Entry Period, and those prizes will not be awarded.

6. Potential Prizes and Approximate Retail Value (“ARV”)

UP TO SIX (6) GRAND PRIZES, one (1) per Entry Period: Each grand prize is \$11,000 awarded via check (“Grand Prize”). There will be up to six (6) Grand Prizes awarded during the Sweepstakes Period, one (1) per Entry Period. The ARV of each Grand Prize is \$11,000.

UP TO ONE (1) FIRST PRIZE: The first prize is \$5,000 awarded via check (“First Prize”). There will be up to one (1) First Prize awarded during Entry Period 1. The ARV of the First Prize is \$5,000.

ONE THOUSAND ONE HUNDRED (1,100) SECOND PRIZES: Each second prize is \$5 awarded via Venmo (“Second Prize”). There will be one thousand one hundred Second Prizes awarded during the Sweepstakes Period. The ARV of each Second Prize is \$5. Venmo payments will be sent to the phone number that was provided upon entry.

UP TO FIFTY-FIVE (55) THIRD PRIZES, eleven (11) per Entry Period, excluding Entry Period 1: Each third prize is a merchandise item, as determined by Sponsor in its sole discretion (“Third Prize”). There will be up to fifty-five (55) Third Prizes awarded during the Sweepstakes Period, eleven (11) per Entry Period, excluding Entry Period 1. The ARV of each Third Prize is at least \$25. Any difference between stated approximate retail value and actual value of prize will not be awarded.

The odds of winning a prize depend on the number of eligible entries received during each Entry Period, during the Sweepstakes Period. The maximum aggregate approximate retail value (“ARV”) of all prizes available in the Sweepstakes, assuming all Entry Periods occur, is \$78,909.

The prizes offered and awarded are not redeemable for cash. Prize details not specified herein shall be determined solely by Sponsor. Prizes are non-transferable, and no substitution will be made except as provided herein at the Sponsor’s sole discretion. Sponsor reserves the right to substitute any listed prize, or component thereof, for one of equal or greater value if the designated prize becomes unavailable for any reason. Alcohol beverages are not part of any prize.

7. Verification of Potential Winner(s)

Potential winners will be notified by email or phone after the random drawing date with instructions on how to claim the prize. IF APPLICABLE: Before being declared a winner, the potential Grand Prize and First Prize winners will be required to execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment (“Affidavit”), sent with the e-mail notification in order to formally accept the prize. Potential Third Prize winners will be required to execute a Declaration of Eligibility/Liability & Public Release and tax acknowledgment (“Declaration”). Winners must respond to the winner notification email and provide the completed Affidavit or Declaration and any other required winner documentation within three (3) days. If any prize notification is returned as undeliverable, or if the potential winner fails to complete the prize claim documents within the stated time period, does not comply with these Official Rules, or if the potential prize winner cannot accept the prize as stated, or if Sponsor, in its sole discretion, deems the potential winner ineligible to receive the prize for any reason, the corresponding prize will be forfeited in its entirety. Sponsor may choose to award the prize (time permitting) to an alternate winner in a random drawing from among the remaining entries received. Administrator/Sponsor will make best efforts to award all prizes. If a Grand, First, or Third prize remains unawarded after three (3) re-draws, the applicable prize will remain unawarded. Unclaimed Second Prizes will remain unawarded. Second Prize winners will receive their prize to their Venmo account in two (2) to four (4) weeks. All other prize winners will receive their prize to their mailing address they provide on their entry submission, with-in six (6) to eight (8) weeks after verification.

GRAND PRIZE AND FIRST PRIZE WINNERS WILL BE ISSUED A FORM 1099, AS APPROPRIATE, FOR TAX PURPOSES IN THE AMOUNT OF THE ACTUAL RETAIL VALUE OF THE PRIZE AND MUST SUBMIT THEIR SOCIAL SECURITY NUMBER, AS APPROPRIATE, AND AS REQUIRED BY LAW. ALL FEDERAL, STATE, AND LOCAL TAXES IMPOSED ON THE ACCEPTANCE OF THE PRIZE ARE SOLELY THE RESPONSIBILITY OF THE WINNER.

8. Entry Conditions and Release

Any personally identifiable information collected during an entrant's participation in the Sweepstakes will be collected by Sponsor, Administrator or other Sponsor designee and used by Sponsor, its affiliates, designees, agents and marketers for purposes of the administration and fulfillment of the Sweepstakes as described in these Official Rules.

9. Publicity

Except where prohibited, participation in this Sweepstakes constitutes each winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any medium, worldwide, without further payment or consideration.

10. General Conditions

Released Parties are not responsible for lost, late, incomplete, inaccurate, stolen, misdirected, undelivered, delayed, illegible, garbled or damaged entries, prize claims, email or mail; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries or prize claims, the announcement of the prize or in any Sweepstakes-related materials. Released Parties are not responsible for injury or damage to participants' or to any other person's computer related to or resulting from participating in this Sweepstakes or downloading materials from or use of the website. Administrator reserves the right to cancel, suspend and/or modify

the Sweepstakes, or any part of it, if any fraud, technical failures or any other factor beyond Administrator's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Administrator in its sole discretion. Any use of robotic, automatic, macro, programmed, third party or like methods to participate in the Sweepstakes will void any attempted participation effected by such methods and the disqualification of the individual utilizing the same. In the event of a dispute as to any registration or entry, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider, Internet service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

11. Limitations of Liability

If any provision of these Official Rules or any word, phrase, clause, sentence, or other portion thereof should be held unenforceable or invalid for any reason, then that provision or portion thereof shall be

modified or deleted in such manner as to render the remaining provisions of these Official Rules valid and enforceable. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. No participant shall have the right to modify or amend these Official Rules. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision and such provision shall remain in full force and effect. In the event of any conflict with any Sweepstakes details contained in these Official Rules and Sweepstakes details contained in any promotional materials (including but not limited to point of sale, television and print advertising, promotional packaging and other promotional media), the details of the Sweepstakes as set forth in these Official Rules shall prevail.

12. Choice of Law and Disputes
